WHEREAS, this information will be gathered and analyzed by an independent third-party and benefit the entire Upper Kobuk area by providing important social, economic and environmental data that can also be used for other purposes;

WHEREAS, the EIS process allows for direct engagement from the City, Tribe and individual residents of Shungnak;

WHEREAS, the Shungnak IRA Council is working in cooperation with the Shungnak City Council to engage in direct government-to-government consultation with state and federal agencies on the proposed road;

WHEREAS, the EIS process allows the Northwest Arctic Borough, NANA Regional Corporation, Maniilaq, the Northwest Arctic Borough School District, and other regional organizations to provide comment during the EIS process;

WHEREAS, the EIS process will include studies that will determine how subsistence resources would be impacted by the proposed road, with particular focus on caribou herds and fish spawning areas; WHEREAS, this resolution does not constitute express support for building such a road, but rather that the

EIS process move forward;

WHEREAS, the EIS process will give other Alaska Native communities along the proposed route all of the same engagement opportunities;

THEREFORE BE IT RESOLVED, that the Shungnak IRA Council fully supports and endorses the process of an Environmental Impact Statement (EIS) for the Ambler Mining District Industrial Access Road project; and

BE IT FURTHER RESOLVED, that the Shungnak IRA Council will take whatever actions are necessary to effectuate the intent of this resolution.
